5. Bidder should necessarily enclose a covering letter mentioning a summary of applied document with proper numbering.
6. Any omission in filling the columns of Financial Bid form (Schedule of Rates) shall debar a tender from being considered. Rates should be filed up carefully by the tenderer.
7. **Bidders are not allowed to submit more than one bid for the same/similar tendered item else all his bids shall be cancelled thereby making him disqualified.**

3. **Bid document/ terms conditions duly signed (each page).**
4. **Copy of PAN Number and GST Number or the same to be written on the letter head of the firm.**
5. **Undertaking stating that no case is pending with Police, Income Tax, Excise and Taxation department against the Proprietor/firm/partner or the Company and the firm has not been blacklisted.**
