A Brief Terms & Conditions: -

1. The bidder shall have to submit an Interest free Earnest Money Deposit (EMD) amounting to Rs. 10,000/- (Rupees Ten Thousand Only) in the shape of crossed Demand Draft in favor of "Medical Superintendent, Regional Hospital Kullu" to safeguard the interests of the department.
2. Bids received without EMD will be rejected straightaway.
3. TENDER FEE: The attached tender document should be accompanied with a tender cost fee of Rs. 500/- (Rupees Five Hundred only) through demand draft favoring Medical Superintendent, Regional Hospital, Kullu payable at Kullu.
4. Tender deposited without tender fees will be rejected straightaway. Tender fees is non-refundable in nature. The bidder will himself deposit tender fees in his own name otherwise same shall be rejected.
5. The bidder shall have to attach copy of GST No. & PAN No. of the firm along with detail of bidder.
6. Self-declaration to this effect that the firm has not been blacklisted from business by any PSU/ Govt. Deptt. /Semi-Govt. Deptt. during the last 3 years.
7. The bids should be submitted in a sealed envelope and marked as "Tender for Reagents" All the documents required as per term & conditions of tender should be enclosed with the bid. The supplier will bear sole responsibility for any loss or damage to goods/material in transit. Nothing shall be paid whatsoever for any loss or damage done by rains, flood or any act of God.
8. The security will stand forfeited if the supply is not executed in time or refusal to supply.
9. The reagents will be supplied on priority basis whenever the supply order is received.
10. The quoted rates will be F.O.R. up to destination i.e. "Regional Hospital Kullu".
11. The TYPED PRICE BID may be preferred to avoid any complications while evaluation of bid.
12. The rates finalized will remain valid for ONE YEAR.
13. The conditional bids will not be accepted at any cost and will be rejected straightway.
14. No advance payment shall be made under any circumstances.
15. All the disputes shall be subject to the jurisdiction of Kullu Court.
16. Medical Superintendent, Regional Hospital Kullu, reserves the right to cancel any or all the bids without assigning any reasons.
17. TDS will be deducted wherever applicable as per prevailing Govt. rules.
18. The Medical Superintendent, Regional Hospital Kullu may terminate the contract at any point of time without a prior notice, in case of unsatisfactory services or non-execution of supplies by the successful bidder.
19. It will be sole responsibility of the firm to follow standard SOPs for personal hygiene of workers engaged for the supplying the articles, to avoid the spread of any communicable disease.
20. Supply should be made within 10 days after issuance of the supply order to the successful firm.
21. Lowest bidder (L-1) will be evaluated item wise, not on the total value of the items.

## B Eligibility Criteria for Bidders

1. The tenderers are requested to study the document carefully before submission of bids and must ensure that the conditions laid down for submission of offers detailed below are correctly and completely fulfilled. The tendering found to be deficient in any respect shall be summarily rejected. The profile of bidder is as per **Annexure-'A'**.
2. The conditional offers and offers with terms and conditions inconsistent with those contained in this document shall not be entertained and shall liable to be rejected.
3. The tender once submitted shall not be allowed to be withdrawn, altered or cancelled in part or in whole. Any departure from these conditions will be liable to disqualify the tender and tenderer and the EMD of concerned bidder will be forfeited.
4. The validity of tender is 90 days only.
5. The tenderer shall deposit the sum of Rs. 10,000/- (Rs. Ten thousand only) as earnest money in the shape of FDR duly pledged in favour of Medical Superintendent, Regional Hospital Kullu and same will be refunded after successful completion of the work.
6. The bidder shall submit price bid in Indian Rupees.
7. The successful bidder shall execute an agreement with the office on stamp paper within 7 days of receipt of letter of acceptance.
8. TDS shall be deducted on billing amount as per Central Govt. instructions.
9. The technical bids will be opened in the presence of bidders or their authorized representative.
10. The financial bid of those bidders who are found to be eligible in the Technical Bids shall be opened.
11. The initial contract is for a period of one year subject to extension at the sole discretion of the Medical Superintendent, Regional Hospital Kullu, HP.
12. Contract will be liable to be terminated by the Medical Superintendent, Regional Hospital Kullu, HP at its discretion in case of unsatisfactory Annual Maintenance Contract services by the contractor.
13. The successful bidder will have to deposit a sum of 5% of the amount of bid as Performance Security to the MS RH Kullu at the time at signing the contract.
14. The contract for supply of lab reagents shall be commercial contract between the Medical Superintendent, Regional Hospital Kullu, HP & the successful bidder. There

will be no employer – employee relationship between the Medical Superintendent, Regional Hospital Kullu, HP and the contractor and/its representative/personnel.

#### 15. PAYMENT TERMS

Payment will be made after the entire satisfaction of the Medical Superintendent, Regional Hospital Kullu. No payment will be made for rejected material. The bidder will have to lift the rejected supply within seven days failing which the office will not be responsible for the rejected supply lying in the office.

#### 16. SAMPLE CLAUSE:-

Bidder must have to furnished samples for each test under procurement in the tender during technical evaluation.

#### 17. PENALTY CLAUSE

Non compliance to terms and conditions will lead to the forfeiture of the performance security.

18. The following documents are required to be submitted along with the bid for technical evaluation: -

- a) The firm must have Permanent Account Number.
- b) The firm must have GST registration No.
- c) The Bidder shall not be under a declaration of ineligibility for corrupt or fraudulent practices or blacklisted by any of the Government agencies as per **Annexure 'B'**.
- d) Tender fee in the shape of DD amounting to Rs. 500/- (Rupees five hundred only) in the name of Medical Superintendent Regional Hospital Kullu payable at Kullu.
- e) EMD in the shape of FDR amounting to Rs. 10,000/ (Rupees Ten Thousand only) duly pledged in favour of Medical Superintendent Regional Hospital Kullu.
- f) Sample of all the regents under tender document along with the technical bid.
